At the time of registration as an NGO Affiliate you will be charged a **one-time, non-refundable** Entrance Fee of Rs. 5,000/-, as well as an annual fee of Rs. 7,000/-.

The Annual Fee is payable in the first week of April at the beginning of every FY, towards the renewal of your affiliation for the coming financial year.

If you do not require our services for an upcoming financial year, you may opt out of paying that year's annual fees. When you wish to resume your access to our services and advice you can pay the annual fee and renew your affiliation. Concessions on fees may be considered for start-up projects if they are found to be deserving of such.
