OUR HISTORY

CENTRE FOR ADVANCEMENT OF PHILANTHROPY was established as a Section 8 (not-for-profit) company in 1986 by Late HT Parekh (Founder HDFC Ltd.), Late Russi M Lala (Director, Sir Dorabji Tata Trust), Late RR Chari (Commissioner of Income Tax, Trusts Circle), Late Ramu Pandit (Secretary General, Indian Merchants Chamber) and Mr Darius M Forbes (Forbes Marshall Group).

At that point of time, CAP was conceived as a 'Chamber of Philanthropy', "to serve as a clearing house of information, widen the circle of philanthropy, provide guidance and assistance to philanthropic organisations, and as and when possible, undertake advocacy work for a more legally enabling environment." Back then, Late Nani Palkhivala had told Russi, "Whenever the Tata Trusts need legal assistance they have Nani Palkhivala, but what about the hundreds of other little NGOs that need legal assistance from the time they start to when they decide to wind up?" Hence, CAP's focus became Legal Advisory and remains our core work to this date.

CEO'S NOTE

Yet another year has gone by and we are about to enter our 30th year!!!

So much has changed within the sector and also at CAP. The demands on the sector are growing and much is expected out of Indian non-profits which are battling with laws which are complex and not entirely enabling. CAP, on the other hand, is sensitive to the changing needs and growing demands, and has therefore made 'Compliance Complete' its new mantra or tagline as it enters a new phase in its evolutionary cycle.

From the governing board and the staff, to donors and other stakeholders, all feel assured that potential risks in their organisation are well-studied, and effective checks are in place to handle them.

Indeed, to be compliant is to be complete!


OUR BOARD



Published here is the Income & Expenditure Statement as also the Balance Sheet of Centre for Advancement of Philanthropy (CAP) for the Financial Year 2015-16.

CAP's financial status appears stable. But, that's thanks largely to the grant support from the Tata Trusts. Set aside the grant and CAP's financial sustainability would appear more than just challenging.

CAP's Corpus fund has grown only marginally from Rs. 2.16 Cr to Rs. 2.26 Cr while revenue from donations and fees has dropped from Rs. 30 Lakhs as on 31-03-2015 to Rs. 19.53 Lakhs as on 31-03-2016.

The Surplus that is reflected in the Statement of Income & Expenditure is the unutilized portion of the program grant received from the Tata Trusts and for which a no-cost extention has been received up to 31st December 2016.

On one hand unrestricted and voluntary donations are difficult to come by, because, every donor wants to support only projects and programs. Add to that an organization providing legal and other advisory services is not exactly an emotive cause.

It's easier said than done to say, "Why doesn't CAP charge higher fees and augment revenue". As the saying goes, "only the wearer knows where the shoe pinches. NGOs generally expect subsidies and where fees are concerned, the Income tax Act 1961 does not allow CAP to generate business income in excess of twenty percent of its total income from donations, grants and other non-commercial heads.

Clichéd as this may sound, we have an uphill task ahead!
